



RULES FOR THE TRAVELER OF PUBLIC TRANSPORT

Anyone get on the bus must obtain a ticket (monthly, fortnightly, subscription or one-way ticket) of the Company Corsi & Pampanelli.

The ticket is strictly personal and should be kept for the duration of the trip and presented at the request of Corsi & Pampanelli' staff (driver and/or controller). The one-way ticket must be stamped for each journey and as soon as you board the bus.

The monthly subscription, however, must be stamped only on the first trip as soon as you board.

The traveler is required to check the accuracy of the date printed on the stamp, any irregularities or failures of the ticket punch must be immediately reported to the driver.

In case of failure of ticket punch, the traveler must cancel the ticket by putting on the same date, time, number of car or station. The one-way ticket can be purchased from authorized retailers or exceptionally on board directly from driver but at higher price.

PENALTIES:

Anyone found by security personnel without the ticket (also if it is just been forgotten) or with a counterfeit ticket or non-stamped (for himself, for animals or luggage), incurs in the administrative penalty from \in 100,00 to \in . 500,00 (Regional law n.16 del 16/06/2003) in addition to payment of the ticket price.

The minimum penalty is reduced by half (\in 50,00) if payment is made directly to the driver or the controller at the time of the investigation of the infringement. The drivers and controllers, in discharging their function, are the status of public official (under the law art. 358 C.P.¹) therefore, travelers, upon request, are required to declare their. The rejection and falsity about the identity, shall be punished by the Criminal Code (under the law art. 496 C.P.²)

Anyone, outside of the cases mentioned in previous articles, when asked about identity, status or other qualities of person or another's person, makes false statement to a public officials, or person in charge of a public service, shall be punished with imprisonment up to one year or a fine of up to two hundred thousand. (corresponding to $\in 103,29$).

¹ Art. 358 – Definition of a person entrusted with a public service.

For the purpose of the Criminal Law, are person in charge of a public service:

^{1°} employees of the state or another public body, which provide a public service, permanently or temporarily;

^{2°} any other person who offer permanently or temporarily, whether voluntarily or compulsorily for free or under remuneration, a public service.

CHILDREN:

Are allowed to free transport children under the age of 4 (four) with height less than m1 (one) provided that they do not occupy a seat and are accompanied by an adult who is directly responsible.

LUGGAGE:

Are allowed free transport of baggage no larger than cm. 50x30x25, foldable strollers or children and musical instruments no larger than cm. 115x50x20. Baggage in excess of even a single dimension, are excluded from free shipping.

ANIMALS:

Are allowed free transport of guide dogs for the blind and the small animals under the conditions of the existing rules. In particular, small dogs should be kept on a lead and muzzled in the basket, while cats should be conducted in special kennels.

FORBIDDEN BEHAVIOR:

It's forbidden: to smoke (Law n. 3 of 16 january 2003); lean from the windows, damage, to damage bus, throwing objects from the windows (art. 27 DPR 753/80); get on and off by sides others than those specified; bring objects in the bus in shape or volume could be hazardous or bother; distributed advertising material not authorized by the Company or the exercise of any type of business; disturb or bother driver or passengers.
